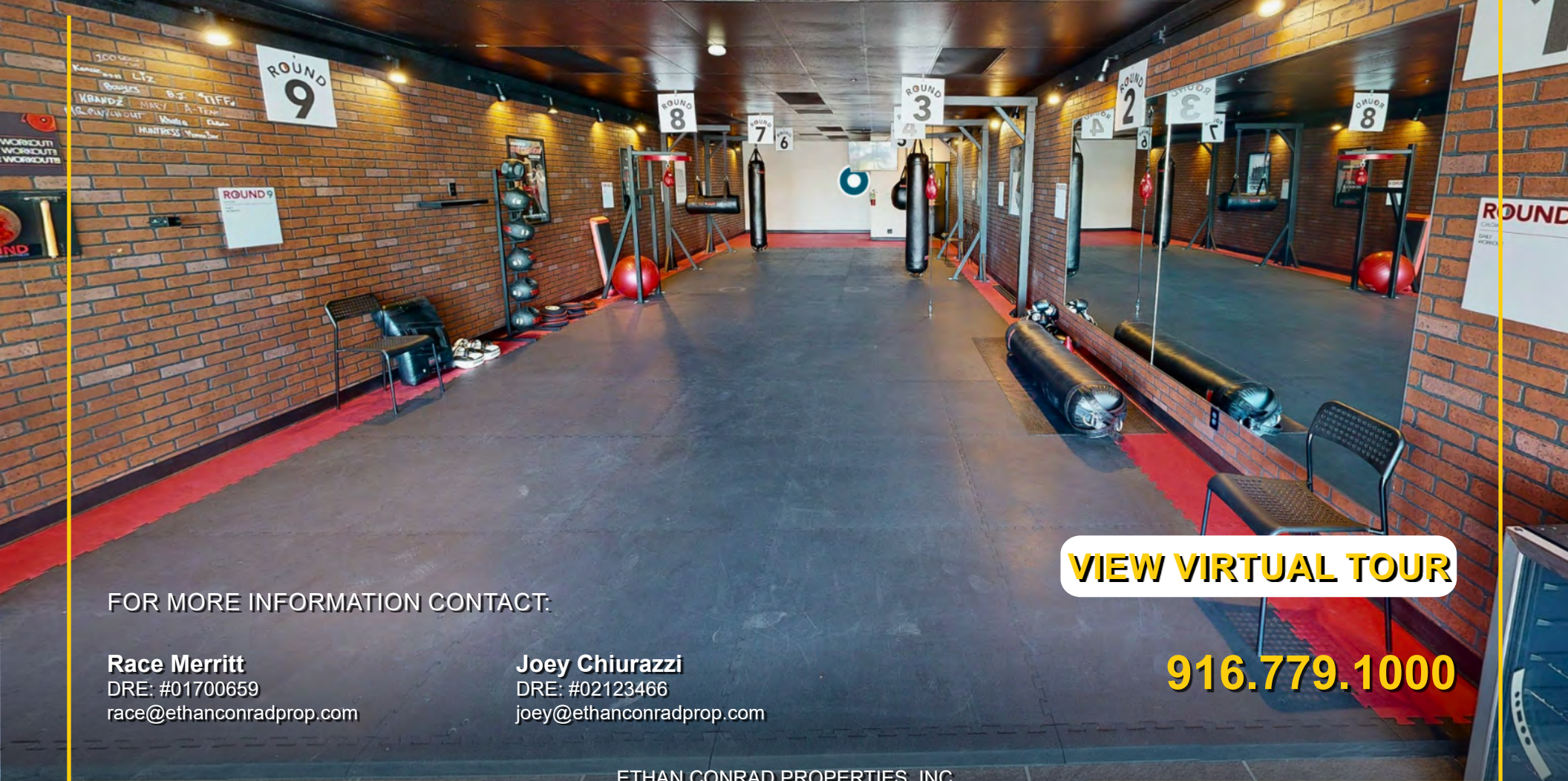

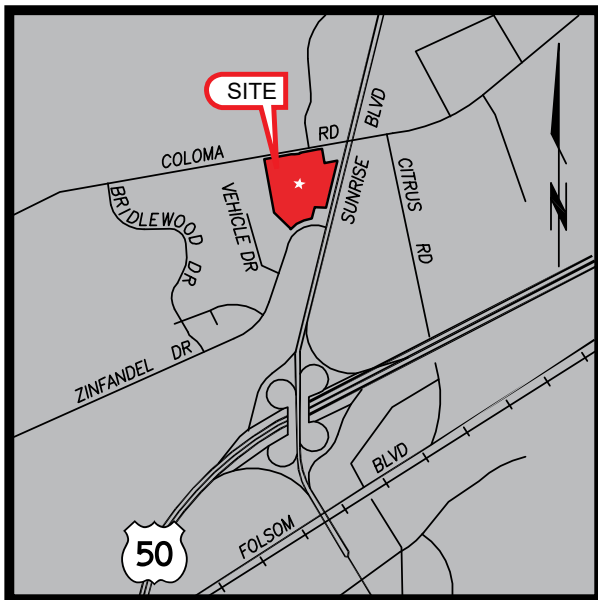

SUITE 20 FLOOR PLAN



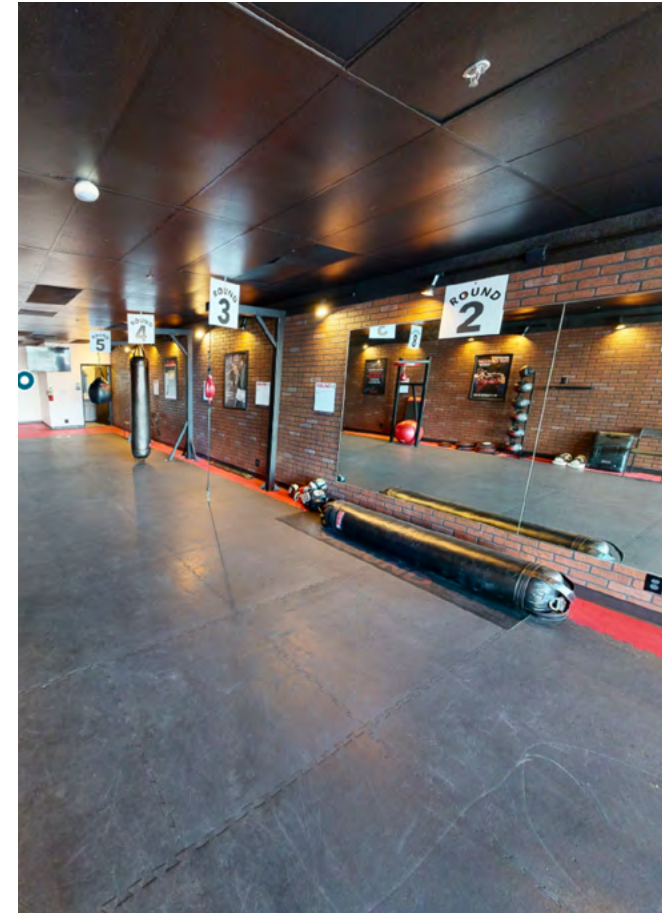

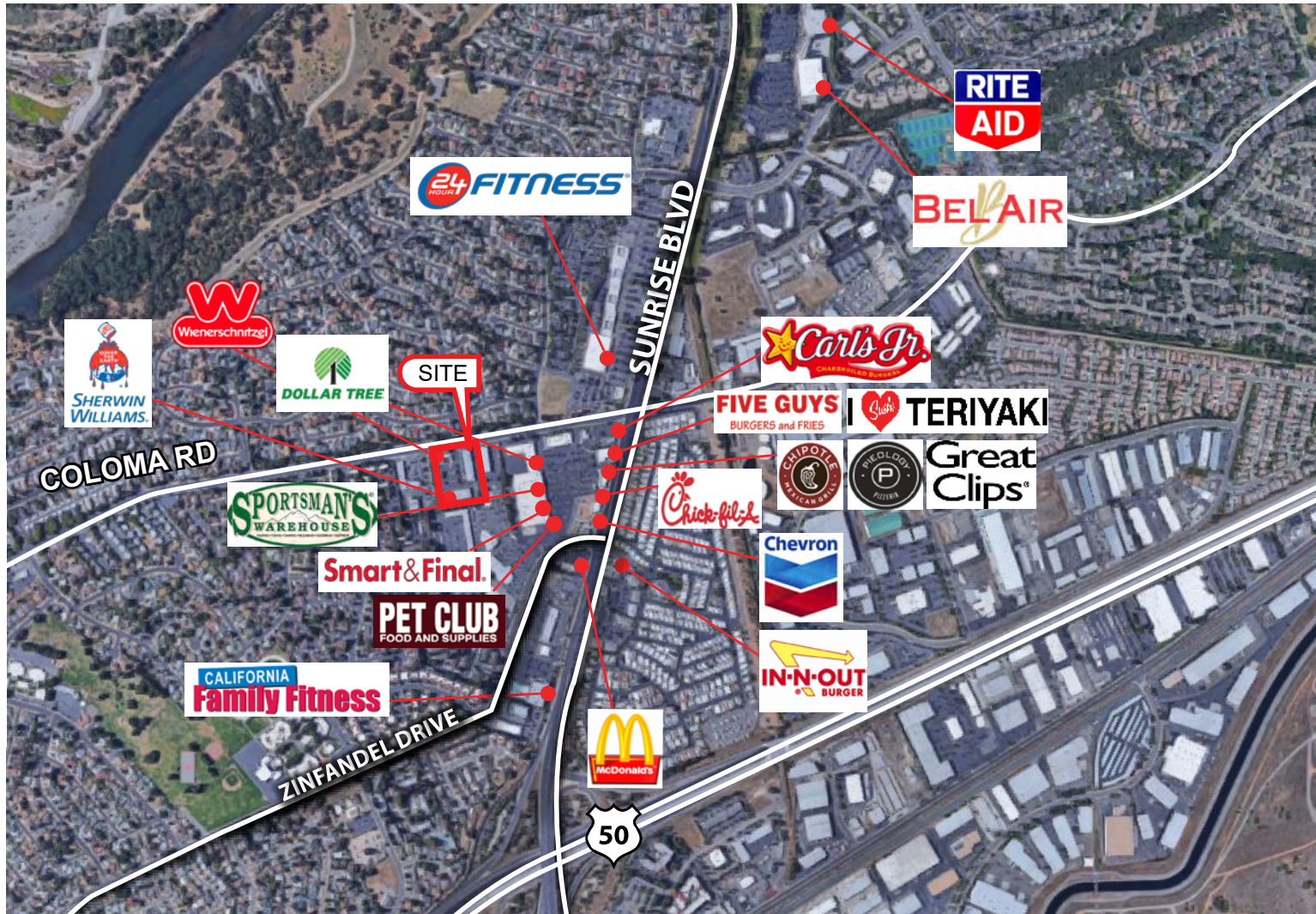
